- 1. <u>Approval of Minutes of the June 28, 2022 Quad Cities MPO Transportation Policy Committee Meetings.</u> Mayor Gerard, sitting in for Mayor Matson, requested a motion to approve the minutes. Mr. Dunn motioned for approval of the minutes as written. Mr. Ortiz seconded the motion, which carried unanimously.
- 2. <u>Update on I-74 Mississippi River Corridor Reconstruction.</u> Mr. Wick shared that the viaduct on the Moline side is mainly completed. Restriping on the bridge, landscaping, and other works continue. Demolition work is in the submittal process, and will be decided by the end of this summer with the approved plan. Letting for the elevator will be in 2023.
- 3. <u>Consideration of Bi-State Regional Intelligent Transportation System (ITS) Architecture</u>. Mr. Wu recapped the process of updating the regional ITS architecture plan. Mr. Wu highlighted the elements included in this update and the revisions to the terminology and architecture structures in the report. A recommendation was made to review this report and the underlying database annually to keep up with the fast development of the ITS industry. The document itself is required to be updated on a five-year cycle.

The updated ITS database and the new report "Bi-State Region ITS Architecture 2022" has undergone review by the Transportation Technical Committee, and was recommended for approval. Approval from the Policy Committee was requested. Ms. Tyler-Jamison motioned for the approval of this report. Mr. Ortiz seconded the motion, and it carried.

4. <u>Consideration of Revisions to FFY2022-2025 and FFY2023-2026 Transportation Improvement Program (TIP).</u> Ms. McCullough directed the Committee to the agenda packet to five amendments submitted by the Illinois Department of Transportation. Illinois DOT approved the state's five year transportation program after the adoption of the Quad Cities MPO FFY2023-2026 TIP. These new projects, all bridge cleaning related on various structures, are requested for approval as amendments IL-23-12, IL-23-13, IL-23-14, IL-23-15, and IL-23-16. Mr. Dunn motioned for their approval, and Mr. Ortiz seconded the motion. The amendments were approved. Ms. McCullough also directed the Committee to more than two dozen administrative modifications submitted from Illinois for city and state projects that were planned for advance construction. No action on these projects was needed, and they were presented for information. A copy of the TIP amendments and administrative modifications approved at the meeting are attached at the end of the minutes.

- 5. <u>Support for Safe Streets for All (SS4A) Planning Grant.</u> Ms. McCullough directed the Committee to a letter of support for the Quad Cities, Kewanee, and Muscatine Traffic Safety Action Plan planning grant request to the U.S. DOT. The letter stated the importance of transportation safety as a key objective in the Quad Cities MPO Long Range Transportation Plan and interest in the Vision Zero fatality reduction effort of the grant program. Mr. Ortiz motioned to approve the letter of support. Ms. Tyler-Jamison seconded the motion, and it carried.
- 6. <u>Public Comments</u> There were no public comments.
- 7. <u>Other Business</u>. The Committee was directed to the following list of upcoming grants for Iowa or Illinois jurisdictions related to safety, air quality emission reduction, and transportation alternatives.
