Consideration of Revision to the FFY 2019-2022 Transportation Improvement Program (The revision to consider is an amendment to the TIP involving project number M-19-02 (TPMS # 341947) on Grandview Avenue. The City of Muscatine requested the project description be amended to reflect the actual project terminus of Pearl Street rather than the Carver Corner Intersection. The new description will read as, "Grandview Ave, from Pearl Street, 2.2 miles to U.S. 61.") Tara Cullison

Consideration of Iowa Region 9 Candidate Projects for Surface Transportation Block Grant (STBG), Transportation Alternatives (TA) Set-Aside Program, and Transportation Alternatives Program Flex Funds (TAP Flex) and Recommendation of Results to be Included in the FFY2020-2023 Transportation Improvement (TIP) (Two candidate projects were received requesting STBG funds, including a joint project from Scott and Muscatine Counties and one project from the City of Long Grove. Long Grove also submitted a TA Set-Aside project application. In Region 9, there are \$345,852 in TA Set-Aside Program funds and \$6,721,831 in STBG funds and TAP Flex funds available for programming through FY2023.
