Appendix B to the Proposed Transportation Plan Telephone Survey Report describes the survey data responses in tabular format. There are 39 variables summarized in all. They are presented in the same sequence as they appear in the structure of the questionnaire.

For each variable a number of separate tables is presented. The first table summarizes the survey data responses for all 1,012 respondents. That is followed by a series of tables that breaks out the survey data by geography. Rock Island and Scott County totals are provided in the second table for each variable. That is followed on the following page by breakouts for Rock Island City, Moline, East Moline, and the remainder of Rock Island County along with Davenport, Bettendorf, and the remainder of Scott County all in the same table.

The tables contain a number of terms that may need to be defined in order to fully understand what each table reports. This glossary of terms is designed to aid in interpretation of the response frequency tables describing the data.

Valid cases are those in which respondents answered the question. Valid cases for each question are recorded in the column marked **frequency** in each table. This column reports the raw number or frequency of respondents who answered the question in a certain way.

Non-valid or *missing* cases are cases in which a useful response to the question was not provided by the respondent. Questions generally are skipped for one of three reasons: 1) the question was not applicable to the respondent and therefore never asked (also known as a “skip” or “branching”), 2) the respondent refused to answer the question, or 3) the respondent did not have a response or was not certain about their opinion in regard to the question. The most common reason a respondent won’t be asked a question is because of branching in the questionnaire.

The *percent* is the percentage of all cases in the sample (all cases that completed the questionnaire) that responded to a question in a certain way. The number of *missing* cases is included in the calculation of the raw percent.

The *valid percent* is the percentage of valid cases that responded to the question in a certain way. Missing cases are excluded from the calculation of the valid percent. It is easiest to make sense of the data by concentrating on the valid percent.
